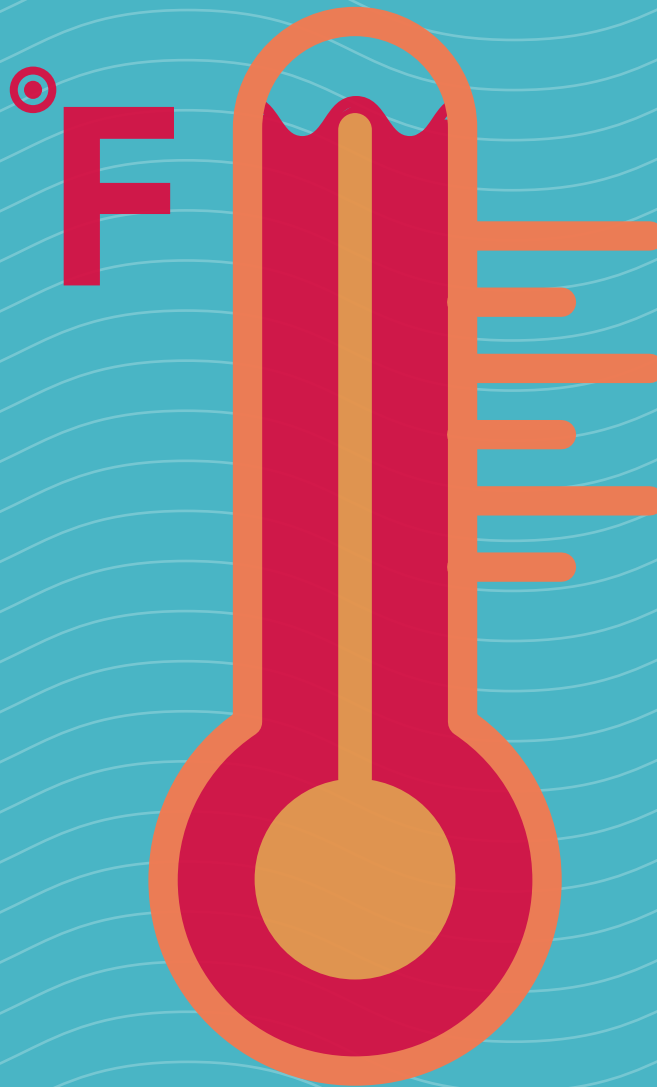

NEWS FROM THE BOARD

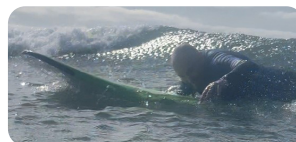
I am not sure how you feel, but I cannot believe that it's July already and our [annual conference](#) is just around the corner! Although the year is flying by, we are making the most of it as we strive to provide you with the services and support you deserve. To that end, I want to update you all on the changes we are working on related to the harassment that was brought to light earlier this year.

First off, I wish to thank all of the members who provided feedback on the draft bylaw language that was circulated at the end of March. I am working with fellow Board members **Tammy Holt** [VP Inclusion], **Brian Wegener** [Chapter Secretary], **Tevya Griffin** [Chair – Planning Directors Group], and **Lorna Parkins** [FAICP Chair] to incorporate that feedback into the final language. This language will be [or potentially has been by the time you receive this] distributed for consideration of a bylaw amendment vote at the annual Chapter meeting to be held at the [conference in Roanoke \[July 16-19\]](#). The key change that we are proposing is introducing Member Advocate positions independent of the Chapter Board. These Advocates are intended to serve as a resource for members who may have experienced any sort of issue at an APA Virginia Chapter event. They are not there to adjudicate the issue, but to provide information and guidance to the member on their options. They may serve as a conduit in bringing issues to the attention of the Board when appropriate. While it is our sincere hope that the need for these services will be very limited, we have been acutely reminded of the need for a safe environment for our members to be able to share their stories and to be advised of their options.

The second item I would like to share with the Chapter is that the Board has identified a harassment training and are in the process of coordinating the attendance of the entire Board in advance of our [gathering in Roanoke](#). As we move forward, we are committed to make this an integral part of the Board's retreat and work plan development during each two-year Board cycle.

Finally, in addition to the vote on the bylaws at the [conference](#), there will also be opportunities for members to discuss with myself, or other members of the Board, questions or concerns they may have about the direction the Chapter is headed regarding the handling of misbehavior related to the Chapter and its events. We have also invited **Karen Wolf**, FAICP, the current President of the American Institute of Certified Planners, to lead our Ethics Case of the Year discussion and share a little on the work taking place within APA nationally on this important topic.

I've been a member of the Virginia Chapter of the **American Planning Association (VA APA)** for almost a decade and have been serving the chapter in a variety of capacities as a volunteer so far. I've had the opportunity to serve as the Director of Northern Virginia Section and the State Delegate representing the chapter at the National Delegate Assembly as well. Both roles have helped me to support chapter's advocacy, professional development, equity, membership, and networking goals. As one of the State Delegates, I worked with my fellow delegates and chapter board to help shape three separate policy guides: Hazard Mitigation; Climate Change; and Equity in Zoning. As the Director of Northern Virginia Section, I worked with a team of fellow planning professionals to create a series of professional development and networking events remotely at the peak of the pandemic (2020-2021).

My request to all the fellow professionals is to participate in at least one volunteer role in your professional career to support the chapter efforts. I guarantee that this experience will be extremely rewarding with the opportunities it provides for knowledge exchange with professionals across the state, professional development, and building life-long professional connections along the way.

Planner's Advocacy Network:

Planners have the in-depth knowledge of current planning issues in our specific areas of work with the ability to foresee future challenges through data analytics and knowledge of the best practices to address those. Hence it is not only essential to have planners as essential partners in the decision-making process at all levels of governance (local, state, and federal

levels), it is also important for us to be on the table to have our priorities reflected in the policies. One such avenue to influence the decisions at the state and federal level is the Planner's Advocacy Network.

*Strong federal action – including effective regulation and additional legislative advances – can ensure that investments in **climate action, infrastructure, and zoning reform** drive planning outcomes that make our communities and our country more prosperous, equitable, and resilient.*

APA VIRGINIA CHAPTER LEADERSHIP CLASS OF

For the first time, APA Virginia offered a leadership class for mid-career professionals to provide guidance, networking, and a peer group to strengthen these planners' career advancement.

The goal of the class is to equip planners to successfully take on greater leadership roles and to be prepared for greater responsibility as future leaders of our profession and communities. The leadership class addresses core leadership capabilities and took place in Richmond on Saturday mornings once a month from January through June. The two-hour class sessions included interactive discussions and exercises, followed by a networking lunch. In addition to the six classes, the participants have developed personal leadership development plans and have connected with a mentor for either an interview or shadowing.

The class is based on a curriculum that was developed in recent years by the APA California Chapter. The APA Virginia class was planned and led by Chapter President Andrew Hopewell, AICP, CZA, and Lorna Parkins, FAICP Chair, with indispensable support from the Eldon James and Associates staff. The series of six classes addressed the following topics, led by volunteer instructors from among Virginia's most experienced planning professionals:

- 2023 APA Virginia Annual Conference - July 16-19 at Hotel Roanoke

Roanoke, Virginia is calling out a warm mountain city welcome for the [2023 APA Virginia Annual Conference](#). The annual conference will take place at the historic Hotel Roanoke and begin on Sunday, July 16, with mobile tours and an evening reception to kick off four days of deep dives into this year's five-star planning points: **Collaboration, Economic Development, Housing, Infrastructure, and the Great Outdoors!**

The 2022 annual conference in Richmond explored Planning for Equity... in sessions from across Virginia and beyond, with an outstanding lineup including keynote speaker Zachary Mannheimer, who showed 3D printing for more affordable housing construction, and Eleanor Sharpe of the Philadelphia City Planning Commission, who shared lessons for civic pride and engagement in community planning. Councilmember Volosin is an at-large member, with priorities focused on environmental concerns and affordable housing. City Manager Cowell has a background grounded in the planning profession before transitioning to leadership-focused roles. His priorities are equity, organizational transformation, and collective responses to community issues. After the welcoming remarks from fellow planners, keynote speaker Dr. Jenny Schuetz, a native Virginian and author of [Fixer Upper: How to Repair America's Broken Housing Systems](#), will share lessons for zoning reform, economics, and other topics fundamental to housing affordability. Monday's agenda continues with the annual chapter meeting luncheon and proposed bylaws vote, breakout sessions, mobile tours, a Planning Commissioner training session, and Monday receptions.

Learning by observing is a key planning strength. Conference sessions related to the five-star planning points will take place in engaging sessions at the Hotel Roanoke and at mobile session locations in the City of Roanoke and areas around Roanoke and Botetourt counties. Attendees will also see the best of planning in Virginia on Tuesday when the 2023 APA Virginia Awards Ceremony and Awards Luncheon showcase the best projects across the Commonwealth.

Opportunities to interact with speakers and other participants are a special focus of the 2023 conference. At the deep dives, mobile tours, quick takes, and breakout sessions, we invite you to come and take part!
